


# Q1 What do you value most about Harwich? (1=most valuable, 5=least valuable)





## Q7 In setting Town priorities, how important is homeowner vs. rental housing?







### Q9 How important is it for the Town to continue to acquire and preserve open space and natural areas in Harwich?







## Q18 How important is it to preserve the historic character of the Town?



### Q19 What are the most important characteristics that should be preserved and/or enhanced in Harwich’s seven villages? (1=most important, 4=least important)











## Q28 Do you own or rent your residence?





### Q30 What is your average commute time to work each day?


